1. Call to order

The Meeting of the SCDS Board of Directors was called to order at 4:01 p.m. by Board of Director Kathy Prahcharov.

2. Roll Call

Kathy Prahcharov took roll call with the following board members present: Steve Prahcharov, Kathy Prahcharov, and Robert Hill (telephonically). Board members Mary Alpaugh and Dr. Heidi Ungar were not present and there were no members of the public present.

3. Approval of Agenda

Kathy Prahcharov moved to approve the agenda of the Board of Directors; seconded by Steve Prahcharov. The motion carried unanimously.

 - a. FSY18 Enrollment Deadlines for 7th/8th grades

Kathy Prahcharov made a recommendation to set enrollment deadlines as:

January 14, 2017 – March 1, 2017: Current SCDS students and new application open enrollment period.

March 2, 2017: Offer of acceptance announced for all applications submitted during the open enrollment period.

March 17, 2017: Acceptance of offer deadline, including submission of checklist items and Student Account payment due to confirm enrollment.

b. Teacher Contracts

During discussion, Steve Prahcharov mentioned that 3 teachers had not yet been offered contracts and a former student teacher had applied for a teaching position. An additional 1st grade and a middle school teacher position was posted and resumes are being reviewed. The motion passed unanimously.
